- Pallium Canada and the Learning Essential Approaches to Palliative Care (LEAP) Courses (2000 to present) In 2002 I co-founded the pan-Canadian Pallium Canada Program with Mr. Michael Aherne. The program's goal is to build primary-level palliative care capacity by diffusing the palliative care approach across different professions and different settings of care. It has evolved into a Foundation, governed by a Board of Directors, with pan-Canadian outreach to every single province and Territory. It has also been used in different ways in several countries, including the Caribbean, Japan and Portugal. The main vehicle for diffusing the palliative care approach are the LEAP courses, of which there are now several versions targeting different settings of care and disease groups, including LEAP Core and LEAP Mini for community settings, LEAP LTC (Long Term Care), LEAP Hospital, LEAP Onco, LEAP Paediatrics, LEAP Renal, LEAP ED, LEAP Hospital, and LEAP Paramedics. Others such as LEAP Heart and LEAP Liver are being developed and LEAP Lung is being planned. Pallium Canada has also undertaken other capacity building projects related to palliative care delivery in Indigenous Communities, Rural and Northern Canada, and Faith Groups, amongst others. In addition, the Program has developed and distributed other products such as the Pallium Palliative Pocketbook (over 40 000 distributed across Canada and adapted into Japanese for use in Japan). In recent years, the program has evolved into a health systems change agent, with the LEAP courses incorporating health systems change approaches and the addition of a compassionate communities program with toolkits to help communities develop these communities. The courseware has also been adopted in various undergraduate and postgraduate programs across Canada, including medical and nursing schools and medical residency programs. There has been an exponential growth in course delivery across the country; in 2018 alone over 330 courses were delivered to over 7000 learners across Canada. This spread has been made possible by a Train-the-Trainer model and a bespoke online learning management system. Pallium Canada has been at the forefront of several innovations, including interprofessional education in continuing professional development (CPD), a large facilitator certification program and integration of palliative care across disease groups and different settings. The LEAP courseware have been integrated into several provincial projects and programs, including Cancer Care Ontario's INTEGRATE Project and Nova Scotia's Paramedics Program. I have been involved throughout the years in a leadership role and have served as Chief Scientific Officer from its inception. Other sub-projects included, among others:
 - Translation of the National Caregivers Guide into Inuktitut for Northern Indigenous peoples;
 - "In Our Own Voices" Program (for health care professionals working with aboriginal peoples);
 - o Protocols for central provincial palliative care telephone call-in services;

 - "Conversations on End-of-Life Care", monthly CPD events delivered by telephone conferencing for health care professionals in rural and remote regions.

Led a project to modify Objective Structured Clinical Examinations (OSCEs) into a different format used for training and formative evaluations. It relies on a coaching approach by faculty, rather than the traditional examination style. The stations developed are now being used to train residents and in the Difficult Discussions Course.

"Not Quite Right" (NQR) Videos" (2004; 2009 and 2011/2012)

Co-developed an approach to developing short educational trigger videos (each 1 to 3 minutes long) called "Ill-structured videos" and later renamed "ill-structured videos". The approach relies on filming vignettes that neither display very poor or excellent communication techniques, but rather show a combination of two and mediocrity. Experience showed that this approach generated more discussion amongst learners than either the "excellent" or the "bad". This approach was also used in the development of a series of similar education videos in Switzerland, in French. These videos are now being used by Pallium Canada as part of its "Essential Conversations" Module.
